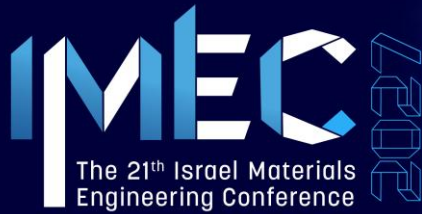

ALLOCATION OF EXHIBITION SPACE
